LANDLORDBC'S BRANDED SWAG BOX GIVEAWAY

CONTEST RULES

(the "Official Rules")

These Official Rules govern the Contest. By participating or attempting to participate in the Contest, you will be deemed to have received, understood, and agreed to these Official Rules.

LandlordBC is pleased to present the SWAG BOX CONTEST (the "Contest"). The Contest will begin on March 1, 2023 and end on April 30, 2023.

1. SPONSORS

The Contest is sponsored and administered by LandlordBC and co-sponsored by Brighter Mechanical, FortisBC, Home Depot Canada, Megson FitzPatrick Insurance Services, Pospischil Realty Group, Refresh Law, Telus, and Yardi Systems, Inc., referred to collectively or individually as the "Sponsors."

2. ELIGIBILITY

The Contest is open to legal residents of the Province of British Columbia and who have reached the age of majority in their province of residence at the time of entry. Employees of Sponsors, its affiliates, subsidiaries, and their respective directors, officers, and agents, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee, are not eligible to participate in the Contest. 3. HOW TO ENTER

Mail-in requests, including both outer envelope and SASE, must be handwritten. Outer envelope must include a return address in the upper left hand corner that matches the requestor's street address, and must be postmarked no sooner than March 1, 2023 and must be postmarked no later than April 30, 2023, and received by Sponsor no later than May 15, 2023.

4. PRIZE/ENTRY CONDITIONS AND RESTRICTIONS

Your entry could be refused or rejected if:

- a. you attempt to enter the Contest in a fashion not authorized by these Official Rules;
- b. your entry contains false or misleading information, or is late, falsified, illegible, damaged or incomplete or otherwise irregular;
- c. your entry is not in compliance with these Official Rules.

In addition, the Sponsors reserve the right to refuse any entry for any other reason as they may determine.

You agree that the Sponsors shall have the right at any time to require proof of identity or eligibility to enter the Contest; failure to provide any such proof upon request may result in disqualification;

5. PRIZES

There are a total of 36 prizes to be won. Each prize for the Contest is one SWAG BOX that includes branded products from the Sponsors. The prize is not transferable and cannot be exchanged for cash or other consideration.

- b. The prize must be accepted as awarded and may not be transferred, unless otherwise determined by the Sponsors. The prize may not be exactly as advertised. The prize is provided "as is" without representation or warranty of any kind by the Sponsors.

6. WINNER SELECTION

The winners will be selected by random draw on May 17, 2023. The winner will be contacted by email or telephone within <u>two</u> days of the draw date.

To be declared a winner, a potential winner:

- a. must correctly answer, without assistance, a time-limited, mathematical skill-testing question to be administered by the Sponsors;
- b. must be in compliance with these Official Rules;
- c. may be required to provide proof of identification to confirm eligibility or to claim a prize, or provide proof that he or she is the authorized account holder of any account associated with the selected entry.

7. ODDS OF WINNING A PRIZE

The odds of winning a prize depend on the number of eligible entries received during the Contest Period.

8. HOW TO CLAIM A PRIZE

Once a potential winner is confirmed as a winner, prize distribution will be promptly coordinated.

We do not sell, communicate or divulge your information to any mailing lists.

If you are a winner, the Sponsors may require you to appear in publicity related to the Contest or to any similar contest.

- 2. you acknowledge that the Publicity Parties shall not be required to compensate you, notify you, or request your permission in connection with their use of any biographical information, unless otherwise prohibited by law.

You release and forever discharge the Sponsors, their respective parents, affiliates, and subsidiaries, any other companies associated with the Contest, and all of their respective directors, officers, employees, agents, representatives, licensees, successors and assigns, and agree to indemnify and hold harmless from and against any and all claims, damages or liability, including any costs or losses related to personal injury, death, damage to or loss or destruction of property, arising out of, or in any way related to:

- (ii) the awarding, receipt, possession, use or misuse of any prize, in whole or in part;

This Contest is subject to all federal, provincial, and municipal laws and regulations.
